Summary Report

Fall 2019 Latent Comparison Print Proficiency Test #19102 Issued: November 7, 2019

On July 29, 2019, Ron Smith and Associates, Inc. (RS&A) shipped the Fall 2019 Latent Print Comparison Proficiency Test #19102. Participants were required to submit their responses no later than September 30, 2019 in order for them to be included in this summary report.

A total of 104 tests were ordered and shipped, with 68 participants returning their responses. <u>This summary report is based on 680 individual responses (68 participants returning 10 responses each)</u>. The test was provided in both digital and/or hard copy format and included ten latent prints and four sets of known fingerprints and palm prints.

The results presented in this report reflect whether or not the participants' submitted results are consistent or inconsistent with the assigned values garnered from pre-distribution testing and outlined in *The Manufacturer's Report* (Appendix 1). The primary purpose of a Summary Report is to provide an overall documentation of all the submitted responses. It is RS&A's intention to go a step further by providing more meaningful statistical results through analyzing the submitted responses in relation to the demographics obtained from each of the examiners participating in this proficiency test. All results and statistics for this test will be outlined through graphs and charts found in the remainder of this report.

Prior to distribution of this test, all of the expected responses were determined to be either "Identification" or "Exclusion"; however, we are aware that some agencies allow for a conclusion of "Inconclusive" in their casework. In designing this Proficiency Test, there was no intention to force a participant to render a conclusion which goes beyond their considered opinion. To satisfy this option, participants were allowed to enter "Inconclusive" as a response. Due to the fact that a participant's "Inconclusive" response does not meet the assigned values, it will appear as an inconsistent response in the summary report and be incorporated as such in the statistical analysis. It will be up to each agency to decide if the participant's "Inconclusive" response qualifies as being acceptable under their policies and procedures.

RS&A strives to maintain the confidentiality of all of its clients and participants. All results are obtained and published using randomly generated test codes. RS&A will not release the identity of any participant without the written consent of the participant and/or the agency involved.




Fall 2019 Latent Print Comparison Proficiency Test #19102

- 1. A total of sixty-eight (68) participants, representing forty five (46) agencies/entities, submitted responses to test 19102. Of those forty-five (45) agencies, a total of only two (2) agencies submitted responses inconsistent with our assigned values.
- 2. Of the two (2) inconsistent responses submitted on this test, both of them were answers of "exclusion". Both participants were not certified, worked as Crime Scene Investigators, have less than three years' experience, work with latent prints less than 50% of the time, have less than 200 hours training, and do not work in an accredited laboratory.
